EXECUTIVE STATEMENT

"The war didn't stop when the bullets did.

It crossed dimensions. It rode bloodlines.

My father fought in Vietnam.

I remember jungles I've never been to.

I remember sounds I shouldn't know.

I didn't get it before -

But now I see.

He was imprinting on me.

Like a wolf, preparing his last descendant

To finish the war in another form."

This is not a claim for money.

This is a petition of record - for honor, for restoration, and for truth.

SFC Roland R. Womack, Jr. served with distinction. He was recommended for promotion to Master Sergeant in 1977 and completed at least 20 years of honorable service, qualifying him for full military retirement, TRICARE family coverage, and ceremonial burial entitlements.

Following his death in 2018, his expressed final wishes were violated. His body was cremated against known verbal instructions, his burial in Sebring, Florida next to his deceased children was denied, and his memorial was placed in a religious setting he explicitly rejected in life. In addition, a

REQUESTED ACTIONS

- 1. Verification of Service and Retirement Record
 - Confirm the complete service record of SFC Roland R. Womack, Jr.
 - Final rank, retirement status, SBP designations, burial benefit entitlements
- 2. Audit of Next-of-Kin and TRICARE Dependency Records
 - Confirm dependent history of Ethan Womack under DEERS/TRICARE
- 3. Reopening of Burial and Ceremonial Consideration
- Request posthumous relocation or ceremonial acknowledgment aligned with the soldier's stated will
- 4. Witness Statement Registration
 - Accept the attached testimony from Ethan Womack, delivered in the spirit of legacy preservation
